Information	EU Market Supply	AIPCE-CEP annually publishes the Finfish Study with the aim of demonstrating the need for imported seafood in production of added value seafood within Europe. In January 2021, WG2 established an Initial FG on Trade to collect data on imports in the frame of various trade policy instruments and to contribute with factual information to the development of an advice on trade policy instruments.
