Information + Decision	Substantiating Green Claims	Following a Roadmap and a public consultation, on 22 March 2023, the Commission adopted a legislative proposal for a directive on “substantiation and communication of explicit environmental claims”. The aim of the legislative proposal is to propose common criteria against greenwashing and misleading environmental claims. Before companies communicate on the covered types of claims, these will need to be independently verified and proven with scientific evidence. On 10 December 2020, the MAC adopted advice inspired by the public consultation. On 24 May 2022, the MAC adopted advice on Product Environmental Category Rules (PEFCR) for Marine Fish for Human Consumption.	Presentation of the legislative proposal by COM representative. Information + Decision	Hygiene and Sanitary Issues (Inorganic Arsenic)	Under Commission Regulation (EU) 2015/1006, the maximum levels of inorganic arsenic in some foodstuffs were regulated. In 2021, EFSA published a scientific opinion on dietary exposure to inorganic arsenic, which called for a reduction in the exposure. DG SANTE initiated the work to revise the regulation. At the 27 January 2023 meeting, it was agreed, as an action point, that, an item on arsenic would be scheduled.
