It is established practice for Commission representatives to deliver updates on the latest trade policy developments affecting the market. There are several trade developments of relevance, including with Mexico, Mercosur, Morocco, USA, United Arab Emirates, and Malaysia. The updates on Mexico, Mercosur, and USA will depend on the status of the corresponding legislative/consent procedures.	Presentation and exchange with DG MARE representatives. Information + Consideration	Fisheries Control Regulation	On 9 February 2024, the amendments of the Fisheries Control Regulation entered into force. From January 2026, new rules on lots and digital traceability rules for fresh and frozen products are expected to be applicable. The MAC provided advice to assist in the development of the corresponding delegated act. While the draft delegated act included two Articles on marking of lots and traceability, these were removed from the published act. Following a feasibility study, traceability rules will be applicable to prepared and preserved products within five years. The MAC also provided advice on the Terms of Reference. Information + Decision	Illegal, Unreported and Unregulated Fishing	Under the Work Programme, the fight against the presence in the EU market of products from Illegal, Unreported and Unregulated fishing and/or forced labour is a priority. On 17 September 2025, EIJ published a report on unregulated squid in the Southwest Atlantic, which includes recommendations to the market States and to importers and retailers. Information	External Fisheries Action	The European Commission will be developing a strategy for “fisheries external action”. The initiative aims to set out a strategic approach and steps to ensure a level playing field. The initiative will be integrated in a broader mission to develop a strategic approach to EU ocean diplomacy and of the EU’s wider regional strategies and priorities. The Commission launched a call for evidence from 7 July to 15 September 2025. At the 18 September 2025 meeting, the Working Group considered draft advice.
